



## Installation Instructions

### **Terralink Data eXchange (TDX™) TDX SERVICE BULLETIN 3 Version Compatibility 2-02-300 \*ONLY\***

**Failure modes:** Selecting proper shipping names that have a hazard class description of "None" don't print the packing group.

**Affected DOT Shipping Names are:**

- \* Combustible liquid, n.o.s, NA1993, PG III
- \* Carbon dioxide, solid or Dry ice UN1845 PG III
- \* Cartridges for weapons, inert projectile or Cartridges, small arms UN0012 PG II
- \* Castor beans or Castor meal or Castor pomace or Castor flake UN2969 PG II
- \* Dibromodifluoromethane , R12B2 UN1941 PG III
- \* Diesel fuel NA1993 PG III
- \* Fish meal, stabilized or Fish scrap, stabilized UN2216 PG III
- \* Primers, cap type UN0044 PG II
- \* Primers, tubular UN0376 PG II
- \* Seed cake, containing vegetable oil solvent extractions and expelled seeds, with not more than 10 percent of oil and when the amount of moisture is higher than 11 percent, with not more than 20 percent of oil and moisture combined UN1386 PG III
- \* Seed cake with more than 1.5 percent oil and not more than 11 percent moisture UN1386 PG III
- \* Seed cake with not more than 1.5 percent oil and not more than 11 percent moisture UN2217 PG III
- \* Zinc dithionite or Zinc hydrosulfite UN1931 PG III

Selecting certain proper shipping names that have an explosive hazard class such as Fireworks don't work.

**Problem Analysis:** Problem was introduced in Service Pack 3. DOT names with the word "None" in the hazard class description did not get fully updated. Some DOT shipping names designated with explosive hazard classes did not get correctly linked to the ERG data which prevented them from being selected.

**Problem Solution:** Updated the Hazard Class with "None" for the shipping names listed above. Linked shipping names which had an explosive hazard class, but did not have a specific mapping to the UN / NA number to ERG 112 or 114 depending on the primary classification.

**Risk involved in performing this update:** None.

\* This is a "Hot" fix; users are NOT required to be logged out of TDX™.

\* You will be required to provide log in credentials for Terralink™ Utility when Service Bulletin update is run for "Server" or "Standalone" installations. Be prepared with your Data Source Name (DSN), and a valid TDX™ username and password.

#### **To Install:**

- 1) Click the "Start" link on the download page to begin downloading 2-02-300ServiceBulletin3 update.
- 2) After the download is complete, double click on the file to start the install.
- 3) Click on the "Install" button to start, and log into Terralink™ Utility when required.

Program will end automatically when installation is finished. **Update should only take a few seconds to complete.**
